

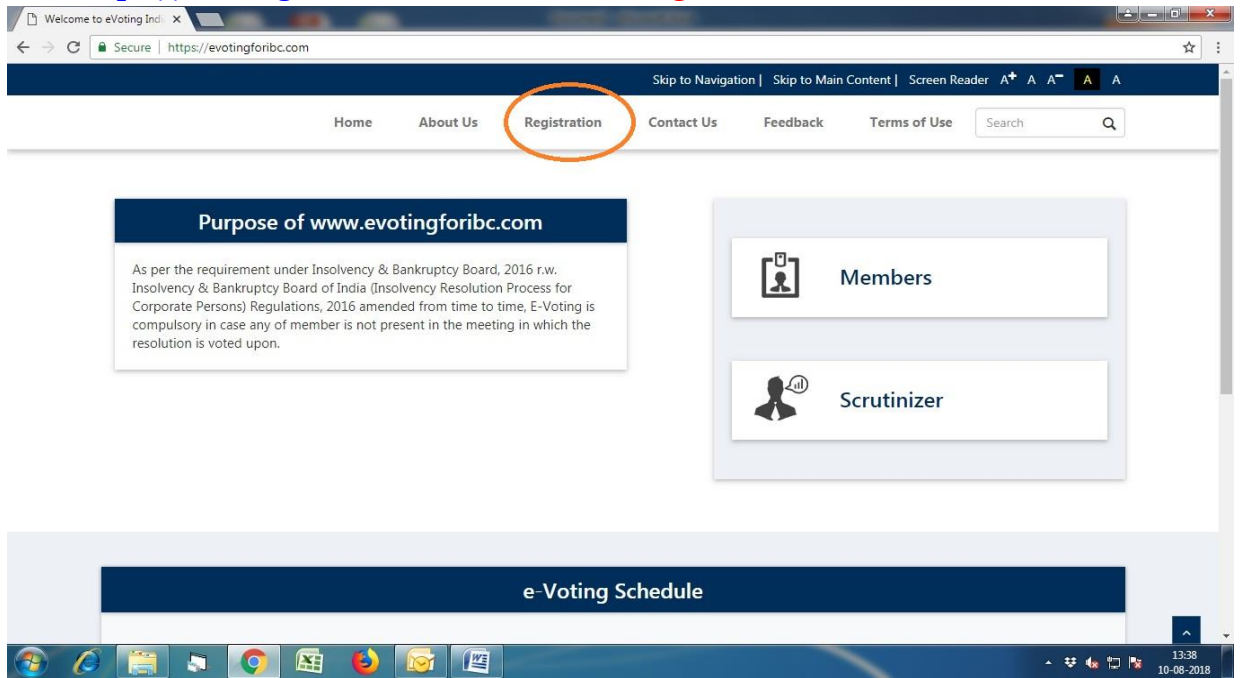

TUTORIALS FOR USE OF E-VOTING SERVICE

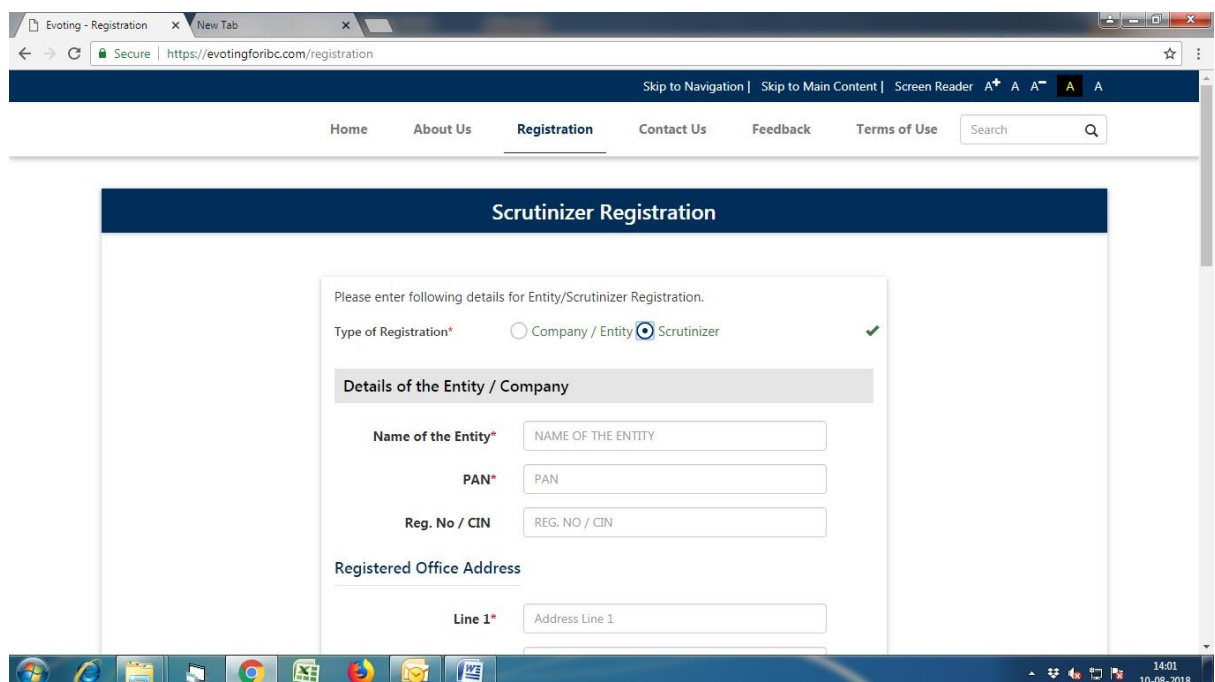
SCRUTINIZER REGISTRATION

Scrutinizer refers to the person who will be carrying out the e-voting process for Company under CIRP. The scrutinizer may be an Insolvency Professional or Insolvency Professional Entity. For the registration as scrutinizer, follow the process given hereinunder.

- 1) Visit <https://evotingforibc.com> and click on **Registration**.



- 2) On registration page, select Scrutinizer.



- 3) Fill the requisite details of the Scrutinizer in the form. In the form “*” mark details which denotes the detail is compulsory to be filled.

After the approval, the email will be sent to the registered e-mail id mentioned in the firm including their Log-in credentials.
